**JURY PROCESS**

**AOTS NON-MEMBERS:** Please submit, per medium, 3 (three) 4" x 6" photographs of the work you will display or sell at the tour. You will be allowed to display **ONLY** the media(s) accepted by the **Jury Committee**. All photos must be identified on the back with your name and medium. Photos will NOT be returned to the artists.

**AOTS STUDIO TOUR REQUIREMENTS:**

1. Artists must only show work in the category or categories approved by the Jury **Committee**.
2. No brokered items, no works by artists other than those juried and accepted.
3. All work must be substantially designed and executed by the accepted artist. Commercially made forms, products, garments, or settings are permitted, but must be significantly modified, altered, combined, or embellished so as to create an original artistic creation.
4. Imported or manufactured items intended for resale, including items made entirely from commercial kits, are **NOT** permitted.
5. Any artists who display items of a type or quality not consistent with that accepted by the **Jury Committee** will not be invited to participate in any future AOTS Studio Tours.
6. Any advertising pieces naming AOTS and Logo produced for distribution must be approved by the **AOTS Board**.
7. All artists must be present at the assigned Studio Tour location, for both Friday and Saturday (tour hours: 9 am to 4 pm), and Sunday (tour hours: 10 am to 3 pm). (**Sunday is optional for Tour Hosts, and will be noted on the map/brochure, Closed Studios**).

**ALL ARTISTS AGREE**

I agree to hold harmless AOTS and will take full responsibility for liability at my studio location.

1. Pieces for display and/or sale are original works made by the Artist.
2. A portion of work will be recent (within two years) and all work displayed will be representative of the images sent to jury.
3. Hold the copyright on all images submitted, and grant permission for Artists of the Superstitions to use these images in news releases, on a website or in promotional material without restrictions.
4. To adhere to all city, county, and state regulations regarding sales tax.
5. To adhere to all city, county, and state regulations for placement of signs.
6. To participate in an advertising campaign via their personal mailing or e-mail lists and social media lists.
7. Cancellation policy, no refunds of payment after acceptance date of August 15, 2025.
